- We do not share your personal data for targeted marketing
- We do not collect or process Sensitive Data to infer individual characteristics

IF YOU ARE A CLIENT

- We provide consultants directly to you or through your trusted providers
- The legal basis we work under in the EU, UK or other locations that require a declared legal basis is the 'performance of a contract'. Data is retained based on contract terms.
- We collect minimal personal data from any of our clients
 - only information required to execute our B2B contract
 - information needed from parties designated by you as contacts for facilitating the contract, performing financial transactions, and managing our services.
 - technical information, like your IP address and ID to allow you access and provide secure and stable services when you connect to and use our system
 - any information that you or the trusted provider you have engaged as a controller to manage our activities as processors requires
- We do not disclose any of your personal data except as you require of us to acquire the services of specialists or individuals on your behalf.
- We never will share or sell your data for our benefit. We use it solely for the purpose collected. We will only transfer it for processing or analytics with your consent.
- Cookies on our site will only do what is needed to provide you services, and what you have allowed them to do through your browser or our cookie consent panel.
- In EU, UK and under similar laws individuals have default rights to access, rectify, delete your data and more. Operating under contract these rights are limited. You always have the right to file a complaint to us or authorities. The information you need to escalate a complaint is listed below in this policy (see the Open Hand icon).
- Where external specialists are required, The Privacy Panel will identify those best fit for any engagement we perform for you. Any contractor we engage on your behalf is bound by our contract with them to perform only the activities for which they are contracted, maintain confidentiality, and protect your data in accordance with the agreements we put in place with you as our client.

IF YOU ARE A SPECIALIST CONTRACTOR

- Any law firm, consultant, or vendor that we engage will self-manage their descriptive data, contact information, and service details in a content management system once under contract with us, and can modify or erase that data at any time. The exception to this is contractual data held while the contract is active or in dispute, until all obligations are met, as the law requires, and the specified term of retention in contract is reached.
- Our contract with you as a service provider is non-exclusive, performance based, and without commitment. It may be cancelled at any time by either party, each required to meet end of engagement commitments defined in our contract.
- The data you provide is protected by the security of the web service. The legal basis for its use is our legitimate interest to provide the hosting, your rights as defined under contract, and by your input of data to our forms, your consent to use the service.
- The personal data that you additionally will need to provide if working as a contractor is limited to only the data that we need to engage you under contract, and to pay you for your services. Under the GDPR we are a controller in any 3rd party relationship.
- Hosting of your information is likely to be in the US or wherever our hosting provider supports as will be the processing of payments.
- We never will share or sell your data for our benefit and will only transfer it for processing or analytics with your consent as will be documented in our contract.
